 - Academic certificate, transcript and/or results slip.
 - Medical Class 1 Certificate.
 - CAAM Approval Letter (if already obtained).
- 2 color passport size photographs.
- 1 copy of Parent / Guardian's NRIC or Passport.

Payment of Enrolment Fee of RM10,000 shall be made in the form of:

- Latest loan account statement(s) / credit card statement(s) / saving account / current account / passbook(s).
- CCRIS report from Bank Negara Malaysia.

5. TERMS AND CONDITIONS OF APPLICATION

The Applicant understands and agrees that completion and submission of this Application Form does not guarantee a placement in the course applied. HM Aerospace Sdn Bhd ("HMA") reserves the right to reject any application without assigning any reasons whatsoever. Admission into the course shall be subject to the absolute discretion of HMA. If the application is accepted by HMA, the Applicant will be issued with a Conditional Letter of Offer. A placement in the course shall only be confirmed upon the Applicant's fulfillment of the conditions contained in the Conditional Letter of Offer, including execution of the Pilot Training Agreement with HMA.
